

Health Insurance

- Self-Funded Insurance Plan
 - Year End FY22-23 \$(1,902,233)
 - Projected FY23-24 \$(2,019,087)
 - 15.3% Increase to Employer & Employee
 - Increase in the County's contribution is \$989,340
- Plan Changes
 - No Longer Covering Weight Loss Medications
- OptumRx
 - No Proposed Changes




COLA





Local Program Funding



Local Agency Program (LAP)

- Used for local projects to develop, design, and construct transportation facilities with Federal-Aid funds (Federal Highway Administration)
- FDOT oversight
- No Local Match



Small County Road Assistance Program (SCRAP)

(FSS 339.2816)

- Used for resurfacing and reconstructing county roads.
- Funds are available to counties that have a population of 75,000 or less per the 1990 US Census data.
- No Local Match

Small County Outreach Program (SCOP)

(FSS 339.2818)

- Used for repairing or rehabilitating county bridges and roads, paving unpaved roads, roadrelated drainage improvements, or capacity safety improvements on county roads.
- Population of 200,000 or less.
- 75% State / 25% Local

Additional Needs



Paved Roadways

- Establishing a pavement preservation program for Paved County Roads.
 - 110 Centerline Miles
 - 220 Lane Miles
- Based on today's cost \$1M per centerline mile every 15 years.
 - \$110 million dollars
 - \$7.5 million/annually

Unpaved Roadways

- Local Unpaved Roads to be paved at some time.
 - 122 Centerline Miles
 - 244 Lane Miles
- Based on today's FDOT construction cost estimate
 - \$305 million dollars
 - \$76 million dollars in potential local match (25% of cost)
 - \$4 million annually

Safe Street and Roads for All (SS4A)

- Bipartisan Infrastructure Law provides \$5 billion grant program, with ~ \$1 billion per year over 5 years.
- Expected Award Size and Requirements
 - Thru R2CTPO
 - Safety Action Plan Grant: \$100K - \$10M
 - Implementation Grant: \$2.5M - \$25M
 - Requires 20% Local Match

Financial Need

FLAGLER COUNTY FLORIDA

- Paved Roads (Pavement Management Plan)
 - \$7.5 million (on average needed annually)
- Unpaved Roads
 - \$4 million annually
- FDOT 5-Year Workplan Program
 - \$1 million annually (Local Match & Cost Overruns)
- Safe Streets and Roads for All (SS4A)
 - TBD (20% local grant match)

Sub-Total FDOT average

\$12.5 million annually

\$5.5 annually

\$7 million - Shortfall annually

Funding Options for Consideration



Ad Valorem (Property Tax)

Dedicated Millage

 $5/10^{th}$ of a mill = Approx. \$7M

Impacts **ALL** Property Owners

½ Cent Small County
Discretionary Sales Tax

Additional \$10.5M Countywide \$4.7M – Flagler County \$5.2M – Palm Coast \$279K – Flagler Beach \$200K – Bunnell
