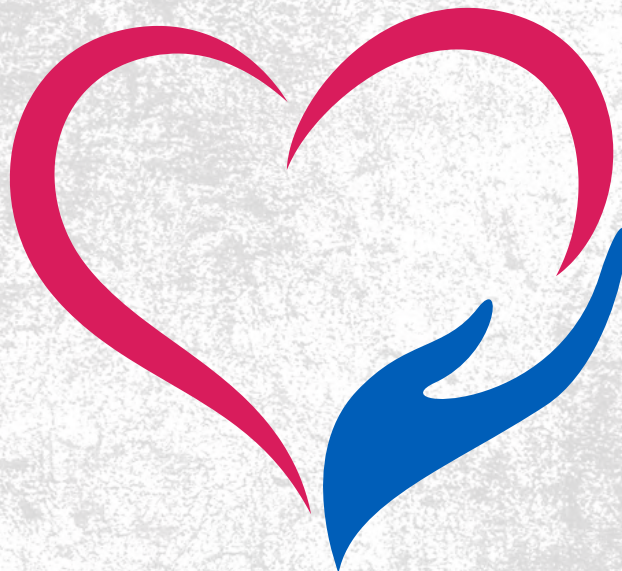

## **What's next after application?**

You will receive notification letters from FEMA either by U.S. mail or by electronic correspondence explaining next steps. If you reported during the application process that you received damage and are unable to live in their primary residence, an inspector will contact you by phone to schedule an inspection.





# FEMA Assistance

## Housing Assistance

Housing Assistance may be provided in the form of financial assistance (funds provided to an applicant) or direct assistance (housing provided to the applicant by FEMA). Most Housing Assistance will be financial.

Housing Assistance Category	Assistance Type
<b>Financial Housing Assistance</b> <ul style="list-style-type: none"> <li>Funds paid directly to eligible individuals and households to secure temporary housing or repairs to existing housing</li> </ul>	Lodging Expense Reimbursement (LER) Rental Assistance Home Repair Assistance Home Replacement Assistance
<b>Direct Housing Assistance</b> <ul style="list-style-type: none"> <li>Provision of direct temporary housing resources</li> <li>Must be requested separately by the State, subject to FEMA approval</li> </ul>	Transportable Temporary Housing Units (TTHUs) Direct Lease Multi-Family Lease and Repair (MLR) Permanent Housing Construction (PHC)

## Other Needs Assistance

Other Needs Assistance is provided in the form of financial assistance (funds provided to the applicant).

Assistance Type	Description
Displacement Assistance	Funds for up to two weeks of lodging-related needs based on a state-identified daily rate. Applicants may request rental assistance if there is a continued disaster-caused temporary housing need
Serious Needs Assistance	One-time payment of \$770 to applicants who indicate an urgent disaster-related need and receive a home inspection
Expanded Clean and Sanitize Assistance	One-time payment of \$300 for homes that are habitable but require cleaning activities (mucking, gutting, etc.)
Funeral Assistance	Funds for expenses related to a death directly attributed to a declared disaster; must be confirmed by Medical Examiner
Medical/Dental Assistance	Funds for expenses related to disaster-caused medical or dental care
Childcare Assistance	Funds for expenses related to disaster-caused disruption of childcare
Personal Property Assistance	Funds to repair or replace personal property damaged or destroyed by a declared disaster that are not covered by insurance; intended to meet basic household needs; amount per item determined by CPI
Transportation Assistance	Funds to repair or replace a vehicle made inoperable as a result of a declared disaster; limited to one vehicle per applicant household
Moving and Storage Assistance	Funds related to moving personal property to a new primary residence or storage of personal property while repairs are being made
Assistance for Miscellaneous Items	Reimbursement for eligible items purchased or rented after a declared disaster to assist with recovery or gaining access to a residence
Group Flood Insurance Policy	Established under the National Flood Insurance Program (NFIP); provides three years of coverage; applicant is required to obtain and maintain flood insurance after policy expiration to be eligible for future FEMA repair/rebuild assistance
