


Southern Library Update

STRATEGIC PLANNING AHEAD AS FLAGLER COUNTY TRANSITIONS FROM SMALL TO MID-SIZED COUNTY





LAND MANAGEMENT PROJECTS:

Worked with the City of Flagler Beach to exchange properties for the mutual benefit of the city and the county, and the residents served. The City inadvertently encroached on the county's property as far back as 1995, likely due to a lack of physical demarcation of the property boundary at the edge of Betty Steflik Preserve. The City has offered 2 contiguous parcels totaling 5.2 acres in exchange for for the county's property that borders city operations. The 5.2 acres is generally characterized as mangrove-dominated wetland and open water. The parcels are located south and west of 14th Street North in the City. The property, if accepted by the County on October 18, would be managed by the Flagler County Land Management Department. The City has purchased and provided surveys and wetland delineations of all Parcels involved to facilitate this land swap.



FLAGLER EXECUTIVE AIRPORT PROJECT UPDATES

1) Consultant Hoyle Tanner has completed the 100% design documents for the T-Hangar facilities. Flagler County Purchasing will put this project out to bid for 30 days in October.


Project Cost: \$117,000 (FDOT \$117,000)

2) Upcoming project to replace Air Traffic Control Tower (ATCT) Equipment. The FDOT has agreed to add an additional \$70,304 to this project to make up the deficit as the lowest bid came in higher than anticipated. FDOT will be sending an Amendment to the Public Transportation Grant Agreement (PTGA), which will be on the BoCC agenda in October for consideration and approval.

Project Cost: \$302,304 (FDOT \$302,304)

3) Design and Rehabilitation of Taxiway A. GAI Consultants authorized for the project, which includes reconstruction of Taxiway "A" from its west end to the west edge of the future terminal aircraft apron, and reconstruction of Taxiway A from the east edge of the future terminal aircraft apron to Taxiway E. Also included in the project is rehabilitation of the Medium Intensity Taxiway Light (MITL) system and pavement markings.

Project Cost: \$185,000 (FAA \$185,000)



(As Flagler County received substantial rainfall in September, the roads and drainage systems saw severe water retention and extensive vegetative growth. There were 30 work requests logged and 88% were completed. Road & Bridge monitored low areas in an attempt to stay ahead of the elements, but are over extended due to staffing shortages. As the weather dries up and the growing season slows down, attention can be more focused on cleaning out drainage areas and mowing. The priority ditch/swale cleaning schedule runs through February 2022. A weekly update is published to social media.)



ENGINEERING PROJECT UPDATES

1) Otis Stone Hunter Road, 2.8 miles. Engineering design services including permitting efforts for the paving of the roadway segment between Main Street and the FEC Railroad, along with the resurfacing of Main Street from CR 13 to Otis Stone Hunter Road and the portion of Otis Stone Hunter Road between the FEC Railroad and US 1. The total project length is approximately 2.8 miles. Permitting efforts have experienced delays as a result of the Navigable Waters Protection Rule redefinition enacted last year. FDEP's assumptions of the "404" permitting criteria has resulted in protracted delays.

2) Rima Ridge Resurfacing, 2.8 miles. This project consists of the engineering design services and permitting efforts for the repair, milling and resurfacing of various roadways in the Rima Ridge area. Consultant, Zev Cohen, preparing 100% plan submittal.

3) Water Oak Road Improvements, 2.5 miles. Engineering design services and permitting efforts for roadway paving improvements and existing unpaved portion from County Road 2006 to Mahogany Boulevard. Finalize bid documents and contract plans. Continue "404" permitting efforts with FDEP.

4) Hargrove Road, 3.6 miles. Design and permitting for paving, Hargrove Grade (Hargrove Road CR 1421) from Otis Stone Hunter Road (CR 1422) to east of the Florida East Coast Railroad. Engineering staff to work with the Environmental Permitting Consultant and FDEP to obtain the project environmental permits.

5) Marineland Acres, 3.7 miles - 8 Local Roads. Resurfacing and drainage improvements. Clearing and grubbing completed. Overhead utility relocations completed. Continue with utilities coordination, Maintenance of Traffic, dewatering, material deliveries, underground drainage structure installations, and watermain installations, as well as roadway construction activities.

6) Apache Drive, 1.15 miles. Roadway pavement and drainage improvements of existing dirt roads to include Apache St., Osceola Ave., and First Ave. Consultant, Crawford Murphy & Tilly, submitted the construction plans and bid documents that included responses to FDOT comments. The SJRWMD permit was obtained.
