Commissioners, the wheels are in motion for *several* new initiatives that will help us to better serve the citizens of Flagler County. Staff is fully embracing efforts to enhance employee engagement, to improve customer service, and momentum is building for the county's strategic planning project, as department heads have met with our consultant Herb Marlowe of Analytica allowing us to move from proposal to plan-of-action.


FLAGLER EXECUTIVE AIRPORT PROJECT UPDATES

1) T-Hangars Construction. Purchasing division, Airport Director, and consultant Hoyle Tanner have reviewed the bids that were received for the T-Hangar construction project. Purchasing will issue a Notice to Award once FDOT funding is received. Requested is \$5,889,723 from FDOT that is 90% of the construction costs for this project. A Public Transportation Grant Agreement is anticipated by the end of February or early March.

Project Cost: \$6,544,136 (FDOT \$5,889,723 and Airport \$654,413)

2) Replace Air Traffic Control Tower (ATCT) Equipment. Signed contract received from CNC NAVTECH and awaiting signature from BoCC Chair. Once signed, a Notice to Proceed will be issued to purchase and install, upgrade the NAVCOM equipment in the Air Traffic Control Tower. Preconstruction meeting has been held, with 120 lead time expected. Project Cost: \$302,304 (FDOT \$302,304)

3) Design and Rehabilitation of Taxiway A. GAI Consultants, Inc. has completed 60% of the design is completed for grading design, drainage design, electrical design, geometry and alignments. Construction Cost Estimate, Design Report, and Project General and Technical Specifications are being finalized and prepared for the 100% Design submission. Project Cost: \$185,000 (FAA \$185,000)





ENGINEERING PROJECT UPDATES

1) Westside Stormwater Master Plan. The goal of the project is identify potential improvements to Flagler County's overall stormwater management program, recommend potential improvements, and design improvements. The purpose of this project would be specifically to mitigate flooding risks to roadways and roadway related infrastructure. January project kickoff meeting between engineering and select department heads. Fulfill consultant initial data requests, and coordinate with City of Palm Coast, City of Bunnell, City of Flagler Beach, St. Johns County, and Volusia County. First initial public meetings are scheduled to occur the last week of February and the first week of March.

2) East Daytona North Paving Project, 3.3 miles. The project scope consists of roadway stabilization with asphaltic concrete pavement and associated stormwater improvements to include a 20 foot wide roadway and stabilized shoulders along various roadways. Field data gathering services (i.e. geotech and survey) are ongoing. Preliminary design concepts to be developed with County Engineering.


3) Marineland Acres, 3.7 miles - 8 Local Roads. Resurfacing and drainage improvements. Central Avenue storm trunk line installed. Over-head utility relocations completed. Continue with utilities coordination, Maintenance of Traffic, dewatering, material deliveries, underground drainage structure installations, and watermain installations, as well as roadway construction activities. 


