Southern Library Update

Construction Management at Risk (CMAR) agenda item was pushed forward to first meeting in July in order to qualify for the Public Library Construction Grant Program for the State of Florida. Worked with County Attorney's Office to prepare the agreement with the Architect.

*Legislative Priorities

- Two out of three of our legislative priorities were funded and Bill SB 620 was vetoed.
- Working on documents for Septic to Sewer Project. Need to be complete and submitted by September 2022.
- Met with City Managers along with the County Administrator and Deputy County Administrator to discuss 2023 legislative session and likely priorities.





GOOD COMMUNICATIONS IS KEY - WE STRIVE TO TELL THE COUNTY'S STORY WELL & OFTEN

Commissioners, defining Flagler County's narrative to share with our residents, businesses, and visitors keeps us busy as we strive to tell our story well and often. With 23 distinct departments and divisions – each with a commanding presence and individual voice – the county's story is a serial that unfolds everyday as a vibrant mosaic of goods and services provided to enhance the lives of residents and visitors alike.

The consistent sharing of Flagler County's details, including photographs from the field, provide the colorful details that add depth to the artwork that is local government. But just because we've shared a glimpse at one of those stories once, doesn't mean we shouldn't revisit it as there are likely some members of our community who didn't see it.

For example, we proudly announced in March 2021 that at the request of Flagler Technical College (FTC) we became part of a much needed program to train adult students to become heavy equipment operators who are ready to hire. We are part of a team that includes the City of Palm Coast and a half dozen private businesses that guide the instructional program.

The Heavy Equipment Operator Technician program at Flagler Technical College was born out of an industry need to replace aging operators with trained professionals, said FTC Director Renee Stauffacher at the time. She thanked the county and the involved businesses for sharing resources for training opportunities to keep the cost of the program down for students.

An advisory committee was formed consisting of local companies that hire operators, including: S.E. Cline Construction; 4C's Trucking and Excavation; J.D. Webber Construction Company; Halifax Paving; P&S Paving; Garney Construction; Flagler County; and the City of Palm Coast. Road and Bridge Manager Ryan Prevatt represents Flagler County on the committee.

The continued need in Flagler County was mentioned recently by one of our residents recently and it served as a reminder that we should share our good stories, like this one, over and over again.





LAND MANAGEMENT PROJECTS:

Land Management received a \$75,000 grant from the Resilient Florida Program that it applied for in August 2021. The grant is intended to fund a Resiliency Vulnerability Assessment for the County. Met with the Northeast Florida Regional Council to discuss supplementing the initial grant with an additional \$75,000 resilience grant.

Land Management met with Randy Jones, a representative of a trust that owns the 2,400 acres along the northern rim of Lake Disston. SJRWMD was in attendance and we discussed partnership on acquisition and potential future regional park location. Rep. Paul Renner toured Lake Disston with some concerned citizens, along with Rob Bradley from the SJRWMD governing board and Mike Register the SJRWMD Executive Director.



FLAGLER EXECUTIVE AIRPORT PROJECT UPDATES

1) T-Hangars Construction. The building has been ordered and the contractor is waiting for a delivery date to be set. Once this is established then the site work will begin. Shop drawings for the civil/site portion of the project have been submitted to the engineer and is under review. The contractor, S.E. Cline Construction, is expected to begin the civil/site portion of the project in August.


Project Cost: \$6.544.136 (FDOT \$5.889.723 and Airport \$654.413)

2) Replace Air Traffic Control Tower (ATCT) Equipment. The Air Traffic Control Tower equipment continues to arrive and is being installed and integrated into the existing system as it arrives and is tested. This is necessary due to the delays in manufacturing and shipping. The installation is expected to be complete in September 2022.

Project Cost: \$302,304 (FDOT \$302,304)

3) Rehabilitation of Taxiway A. The bid results and the grant application packages were sent to the FAA for review. The FAA responded with their available funding amounts, along with preliminary determinations of what they deem to be eligible/ineligible costs. A review meeting is scheduled with the FAA on July 18 to review their comments and discuss the next steps moving forward toward construction.

Project Cost: \$3.97M (FAA \$3,571,400 | FDOT \$317,458 | Airport \$79,364)





ENGINEERING PROJECT UPDATES

- 1) Flagler County Storm Water Master Plan, to identify potential improvements to the county's overall stormwater management program. The purpose of this project is specifically to mitigate flooding risks to roadways and roadway related infrastructure.
- Develop stormwater infrastructure inventory.
- National Pollutant Discharge Elimination System (NPDES)/MS4 permit consultation continues.
- Preliminary permit plan development completed and provided to impacted County Depts. for review and final input.
- Long-term goals: draft Master Plan = 60 weeks and final Master Plan = 72 weeks.
- 2) East Daytona North Paving Project, 3.3 miles. The project scope consists of roadway stabilization with asphaltic concrete pavement and associated stormwater improvements to include a 20 foot wide roadway and stabilized shoulders along various roadways. Completed field data gathering services (geotech and survey). Design concepts to be developed and discussed with County Engineering.
- Estimated design completion = November 30, 2022.
- 3) Marineland Acres, 3.7 miles 8 Local Roads. Resurfacing and drainage improvements. Watermain along Surf Drive is near complete. Contractor has received DEP Clearance on Central Ave. Watermain installation, now awaiting to connect water services and begin removing/grout filling unnecessary existing segments to make way for remaining storm drainage and roadway construction. Contract Amendment 2 work is underway also, including additional driveway and drainage work.
- Final completion by August 9, 2023.
- 4) MalaCompra Road Resurfacing, .73 miles from State Road A1A to the Atlantic Coast Beach. Board approved award of Construction contract to P&S Paving and CEI contract to Consor Engineers. Long-term goals:
- Estimated completion is December 22, 2022.
- 5) Water Oak Road Paving Improvements, 2.5 miles from County Road 2006 to Mahogany Boulevard. Design phase completed. Final reimbursement invoice submitted to FDOT. Bid award to P&S Paving was approved by the Board on June 6.
- Ground breaking ceremony scheduled for August 2
- Estimated completion of construction is Spring 2023.



- In spite of rising interest rates, residential sales in Flagler County remained strong in May 2022.
- Percentage increase of the median sale price between May 2020 - May 2022: Single Family Homes = 64.60% and Townhome/Condo = 45.74%
- Percentage increase of total volume of sales between May 2020 - May 2022: Single Family Homes = 164.7% and Townhome/Condo = 200%
- Prices on closed residential sales continue an upward trend in May 2022: Median Single Family = \$399,900 and Median Townhome/Condo = \$342.500
