

# Flagler County Cottages Reservation Rates

## Per Night Rates\*:

Weeknights......\$ 125 (Monday - Thursday)
Weekends......\$ 150 (Friday, Saturday & Sunday, Holidays, and Special Events)
Security Deposit......\$ 200
Discount.......Weekly Rentals (7 days) receive one free night (totaling 8 nights).

Maximum Stay ..... 2 Weeks (cannot combine multiple rental periods without 1 week break in between) Holiday / Special Events... 3 Night minimum

## **Additional Reservation Information:**

# All reservations must be paid in full, at the time reservation is made.

- Reservations Fees and Security Deposit are payable by cash or credit card.
  - o Cash or credit card payments must be received at least 72 hours prior to check in.

# In addition to payment in full, Guests must provide a completed, signed copy of the Flagler County Cottage Rental Agreement before checking in.

# Flagler County Cottages Reservation Information

## **Security Deposit Information:**

- A \$200 security deposit is required before Check-in:
  - o 72 hours prior to check-in if paying by cash or credit card.
- Deposit refunds are issued within 45-60 days following checkout.
- Deposits may be drawn against for full or partial refunded due to any of the following:
  - 1. Damage caused to the property, furnishings, or supplied equipment;
  - 2. Dirt or other mess requiring excessive cleaning;
  - 3. Any other cost incurred by Flagler County related to guest's stay.

## **Cancellation Charges:**

- For all cancellations, please contact the Parks & Recreation office at 386-313-4020
- Reservation Fees are only refundable for cancellations prior to Check-in.
- Cancellation Refunds will be given for the following periods prior to Check-in:
  - o Greater than 90 days...... Full refund less \$20 admin fee.
  - o Between 31 & 90 days......Full refund less \$100 admin fee.
  - o 30 days or less......Full refund less \$200 admin fee.
- All cancellation charges incurred are per unit and rental period reserved.

## **Changes or Transfers:**

- Reservations can be altered (not cancelled) one (1) time without penalty, when made greater than 90 days from the time of Check-In.
- All additional changes (not including cancellation) will incur a \$20 admin fee.
