#### **LIBRARY GLIMPSE:**

Flagler County Public Library saw a tremendous bump in August for in-person visitors. While foot traffic was 15,609 in July, August saw almost twice that number.

 3,615 voters accounted for some of the 14,700+ increase. Early voting was available at the library between August 16 and 23

### F IS FOR FISCAL ACCOUNTABILITY ALSO FLEXIBILITY, FELLOWSHIP, FOCUSED ON THE FUTURE, AND MOST IMPORTANTLY: FOR FLAGLER

Commissioners,

As we approach the transition to a new fiscal-year, I've had the opportunity to reflect, more than once, on the professionalism of staff, whose efforts underpin the success of the budget process. Your Financial Services team stewards the county's – *ultimately the citizens'* – resources year-round, and every BoCC department and constitutional office is invited into the process for eight months of the year.

You have just adopted Fiscal Year 2022-23 Budget, which supports the Board's priorities, highlights public safety, and reduces the operating millage and debt-service millage rates.

You may recall my earlier message of Flagler FIRST.

In that, F speaks to Fiscal accountability, which you provide in great measure. But another 'ability' you will find in abundance on the Flagler team is Flexibility. Their willingness to think outside the box, to test and measure alternatives, and provide you with a clear analysis of outcomes, supports your ability to remain agile as you balance revenues to obligations.

F could represent Fellowship. When needs outpace funding, decisions are made at the micro level that are best for the organization at the macro level. When your organization views their cohorts as fellow teammates and the ultimate goal as a win for the community, this becomes possible.

While the highlights are many, we still anticipate growing pains. Continued inflation, delayed capital improvements, and an observable increased draw on services – fire and medical response (pg. 2), growth management (pg. 5), and library use higher than pre-COVID (this page) – are all challenges we will face. But I have no doubt that this agency will strive on every occasion to best serve our community.

On the heels of this budget cycle, you have all echoed my appreciation for the commitment of the Flagler team. And I am buoyed by your input, setting direction for a refresh of the budget mechanisms. There is always room for improvement, and I believe this will allow staff to present you with an even more transparent procedure, built for our future.

#### FLAGLER EXECUTIVE AIRPORT UPDATES

T-HANGAR CONSTRUCTION - Aug 11 - Notice to Proceed was issued to S.E. Cline. Drainage work will be followed by new access road.

<u>AIR TRAFFIC CONTROL TOWER EQUIPMENT</u> - Majority of towerequipment replacements are now installed and operational. Vehicle radio-equipment is installed.


TAXIWAY A and GENERAL AVIATION TERMINAL RAMP - Halifax Paving agreed to the project revisions requested by FAA, bringing price down. FAA funds are expected in September.

Director Roy Sieger, as Chair of FL Airports Council, led the group's 53rd Annual Conference & Exposition of 840 attendees and 90 exhibitors. Governor DeSantis spoke to the conference and was presented the 2021 Aviation Leadership Award.

The airport is working with AdventHealth Hospital, facilitating the trauma helicopters at FIN, while Advent's helo pad is closed and being worked on for 3-4 weeks. A joint simulation-drill was held August 11. All went as planned.

Director Sieger met on August 19 with FDOT and FAA representatives to discuss the Executive Airport's 5-Year CIP Plan.

#### **ENGINEERING PROJECT UPDATES**

#### **DUNES PROJECT. NON-FEDERAL:**

#### Design & Permitting of Non-Federal SR A1A Protection within the City of Flagler Beach (FDOT)

Dune and beach nourishment Design-project comparable to ACOE project. Planned for the shoreline in the City of Flagler Beach, from roughly 20th St. N to 7th Street S, and from 28th St S to the Volusia County line.

- Project design is complete however, due to significant changes in existing conditions (erosion) plan updates are needed before bidding the project for construction
- Procurement of easements in process
- Extension request for Bureau of Ocean Energy Management lease submitted

#### **DUNES PROJECT. FEDERAL:**

#### Coastal Storm Risk Management Project (ACOE)

"Hurricane and Storm Damage Reduction Project" as prepared by the US Army Corps of Engineers. This Construction-project is planned for the area of shoreline from 7th St. S to 28th St. S in Flagler Beach. It bridges the two areas included in the county's Non-Federal initiative.

- Plans and specifications have been prepared and regulatory agency permits and authorizations obtained. Legal department activities for procurement of easements remain ongoing.

#### FEMA PROJECT PW215 - HURRICANE DORIAN

#### **Northern Flagler County Coastline**

Due to the impacts of Hurricane Dorian, Flagler County applied for and received approval of Public Assistance funding from FEMA in the amount of \$2,036,868 (75%) and FDEM in the amount of \$339,478 (12.5%) with local cost share of \$339,478 (12.5%). These funds are for activities that include project design and permitting to replace 49,544 cubic yards of sand and 69,612 dune plants along eligible portions of the northern County coastline (5 miles)

- FEMA confirmed funding to be based upon actual costs
- Expect FDEP permit in September and will begin procurement activities



#### **REAL ESTATE**

- Although overall sales have decreased, median saleprices for residential units continue higher
- Between October 2019 and July 2022, the price of residential properties (right) increased dramatically
