### New Facility - Southern Library Update

- With the Architect and Construction Management At-Risk (CMAR) group, we reached the 15% Construction-Document milestone, including basic floor plans and elevations.
- Received estimates from CM, and met in-person and virtually with Ajax and Rhodes & Brito to reconcile those figures to the budget.

## MEETING EVERYDAY MILESTONES DURING EXCEPTIONAL CIRCUMSTANCES

Commissioners,

As summarized in last month's highlights, September saw the BoCC adopt the county's Fiscal Year 2022-23 Budget, which supports the Board's priorities for our community and highlights Public Safety, while reducing the operating millage and debt-service tax millage rates.

October, the first month of FY 2022-23, is now mostly behind us. The accounting transition – the first utilizing Tyler/ Munis software – has been going smoothly. Dashboard reporting, shared visibility of transactions, and the automated chart of approvals and workflows have greatly increased the efficiency of year-end closing processes, even while the current fiscal transactions proceed. Kudos to the accounting teams across the Government Services campus.

Also, mostly in the rearview is the 2022 Atlantic Hurricane Season, which continues through the end of November. But as Jonathan Lord often points out in preparedness-outreach to staff and our residents: "It only takes one."

On September 28, Hurricane Ian made landfall in southwest Florida as a Category 4 Hurricane, weakening as it crossed the state, ultimately to Tropical Storm status. The storm exited over our east coast with hurricane-strength gusts, soaking rains – with reports of local pockets exceeding 20 inches. The storm affected the entire length of our shoreline with devastating impacts to the beach, dunes, homes, businesses, and infrastructure. It inflicted inland damages, where residents and agricultural interests dealt with, and continue to cope with, the effects of significant flooding. Federal, State, and local State of Emergency declarations were enacted.

Emergency Management reports that September 26 began a seven-day Activation, with 21 hours at Level 2, proceeding to 72 hours at Level 1, or "Full Scale" status. The 24/7 Call Center fielded 1,600 calls, 26 wellness checks were initiated, and 35 flooding reports were taken. And while activities were intensely focused during that time, we know that the heavy lifting will continue through October, into the coming months, and beyond. Staff and I will continue to keep you updated.

We will soon publish the 2023 Legislative Priorities booklet and overview cards, as well as the BoCC's 2022 Strategic Plan booklet. You may notice that Staff Reports now include Strategic Plan information, tying daily efforts and 'asks' specifically to the desired strategic outcome. As always, thank you for your guidance and I welcome your questions and follow-up.

Environmentally Sensitive Lands Program and Land Acquisition Committee updates:

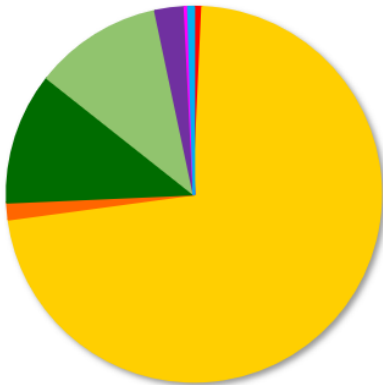
- Carl Landrie was appointed to the LAC

## FLAGLER EXECUTIVE AIRPORT UPDATES

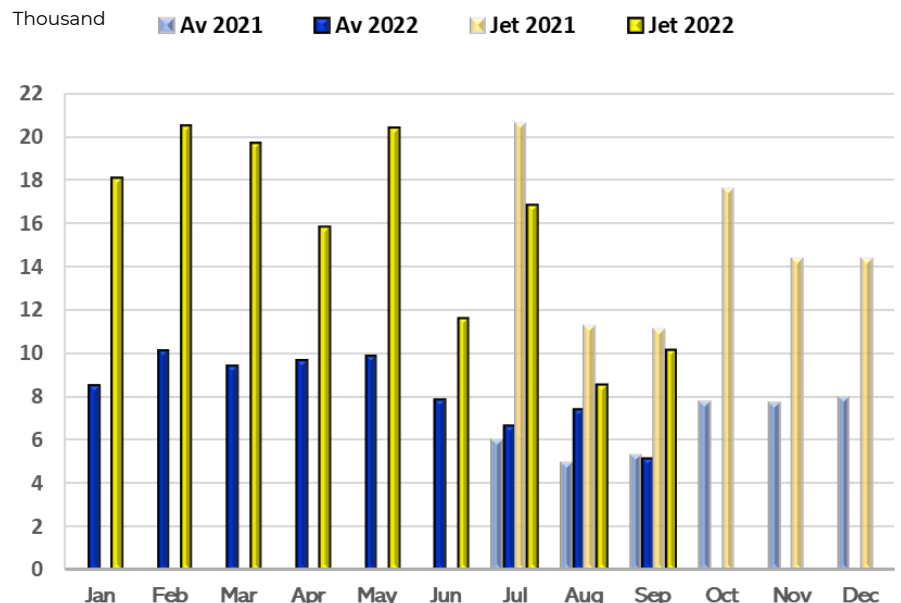
**T-HANGAR CONSTRUCTION** - Temporary hold: The design specified 36" storm pipe for extensions, but construction onsite uncovered 54" existing. Hoyle Tanner is working with S.E. Cline to determine the cost of matching the extension to existing.

**AIR TRAFFIC CONTROL TOWER EQUIPMENT** - Only remaining installation is the backup weather system, slated for December 2022.

**TAXIWAY A and GENERAL AVIATION TERMINAL RAMP** - On Sept. 7 the BoCC accepted FAA grant totaling \$6,634,713. Have requested the FDOT portions, and on receipt, preconstruction meetings will set start-dates for both projects.

**HURRICANE IAN** - Airport became staging site for FPL on Sept. 29. Assets were redirected from Daytona Speedway, which flooded. Utilizing the northside Main, Corporate, Delta Engineering, and FBO ramps, Taxiway B and portion of G, FIN accommodated 1,000 utility and vegetation vehicles. Also, facilities to support the utility and vegetation workers, including sleeping quarters for 1,020, showers, laundry, and a 4,000 sq. ft. dining facility. Hot breakfasts and dinners were provided. Airport staff are very appreciative that we are able to accommodate the FPL Restoration crews, as they quickly get the power back on in our community.

**While not a comprehensive list, some storm preparations performed by General Services Personnel included:**

Assessing roadways and addressing areas of concern, to include surface conditions, drainage, roadside litter and illegal dumping; managing parks - facilities and guest reservations, availability of sand, sufficient safety barricades and signage; setting up amenities and managing deliveries (cots, etc.) in support of shelters and activated staff.

Personnel also reported to the EOC for activation prior to and throughout the storms' movement through the County.

Staff in-field sent constant updates to the EOC for the situational report as closures and repairs were initiated.

Public Works and EM staff partnered with Mosquito Control to perform damage assessments from their helicopter.

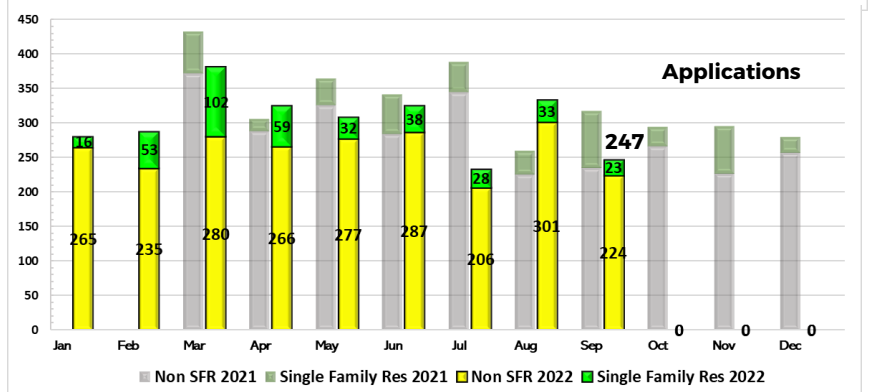
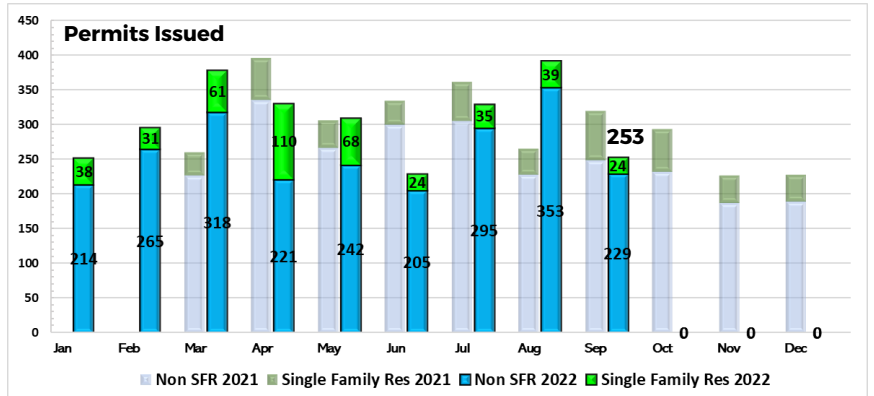
# GROWTH MANAGEMENT UPDATES

8. Land Development Technician and Building Inspector II positions started this month.

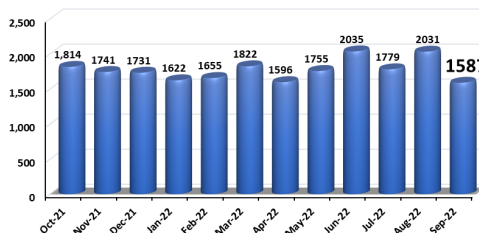

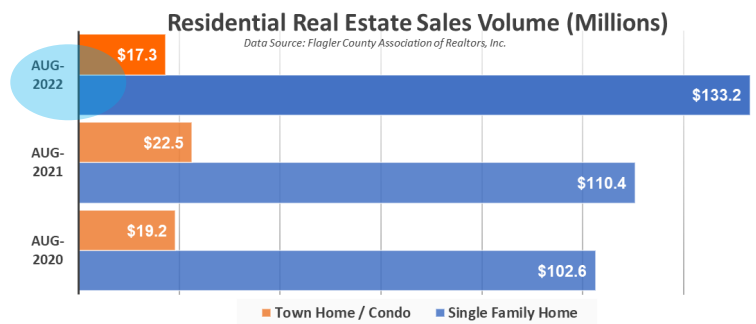

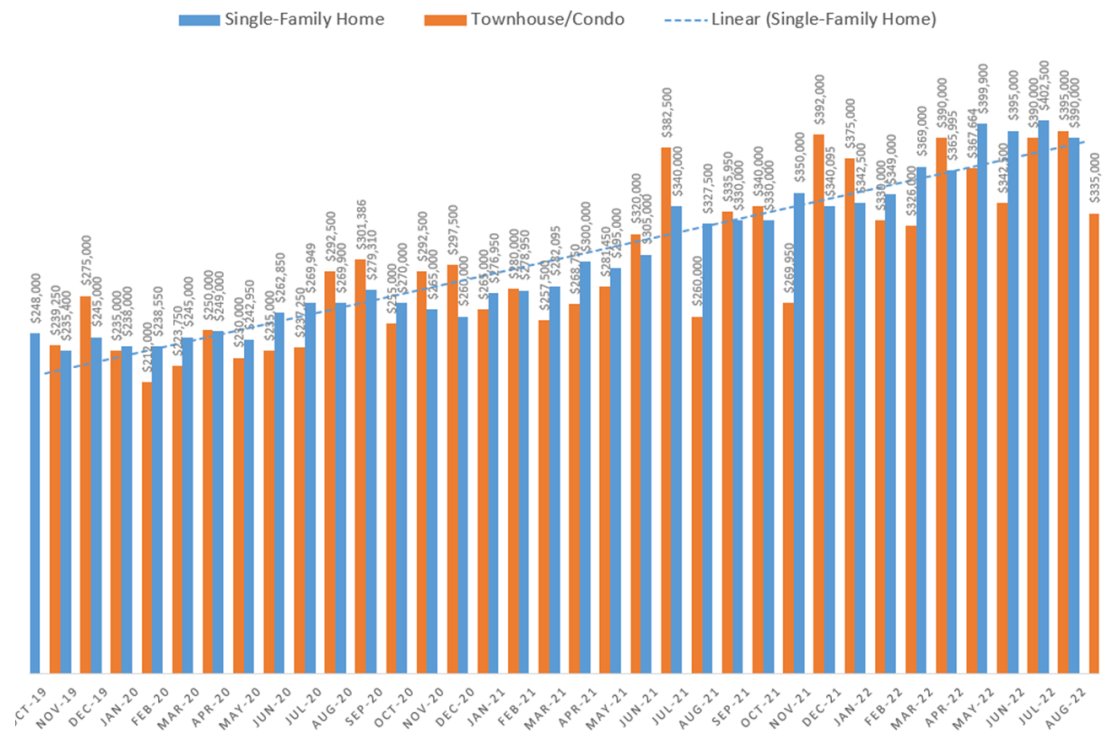
