### WARM (Women Assisting Recovering Mothers)

Women Assisting Recovering Mothers (WARM) serves as a residential treatment facility for women exhibiting symptoms of drug and alcohol dependence. The program serves women who are pregnant, postpartum, and parenting children up to the age of six years old. Children over the age of six are eligible for weekly visits with their mother. Children living on-site receive care from Easterseals' Child Development Center.

WARM Continuing Care and Recovery Support integrates discharge planning, including transition services and recovery support with the Strengthening Families<sup>™</sup> Program (SFP), a nationally recognized parenting and family-strengthening program for high-risk families. #### What To Expect?

Access To access services call (800) 539-4228 or walk- in to 103 E. Moody Blvd, Bunnell, FL during regular business hours.

Screen A member of our Flagler Access Team will ask you some questions such as name, address, phone number and the nature of the care you are seeking.

Intake A face-to-face assessment will be scheduled with a Flagler Access clinician to determine what services SMA can assist you with in helping you achieve better health.

Service Feel free to bring someone with you to this appointment. Plan for the assessment to take between 1-2 hours. If needed, our staff can assist you in finding agencies and resources in the community whose services best match your needs.
