
T-HANGAR CONSTRUCTION - Contractor S.E.Cline completed all elliptical drainage pipe and structures along taxi-lanes. Building pad preparations complete. Work begun on connector road. Sub-contractor M&M Development obtained permit for Building "F" and footer construction on pad is complete.

<u>AIR TRAFFIC CONTROL TOWER EQUIPMENT</u> - No change. Backup weather system: The final installation slated for December was delayed due to issues obtaining part. Installation should be completed in the next month or two once that is available.

TAXIWAY A- Construction Notice to Proceed planned for March 27. GENERAL AVIATION TERMINAL RAMP - No change. Halifax Paving (Contractor) is preparing for construction. Hoyle Tanner (Engineer) is in the process of approving shop drawing submittals. Once coordination is complete, NTPs will be issued. Due to the 25-week lead-time for drainage structures, it is anticipated that construction will begin by July- August of 2023. ENTERPRISE CAR WASH FACILITY & PARKING LOT EXPANSION - Building pad complete and concrete poured. Majority of the block-building constructed.

ENGINEERING PROJECT UPDATES FEBRUARY

HURRICANE IAN AND NICOLE EMERGENCY SAND

12/05/22 - County executed \$5M FDEP Agreement 23FL1 for emergency sand placement along those most severely impacted dune systems.

Sand will be placed to reconstruct dunes to a fill-density of 6 cubic yards per linear foot in areas where there are no other ongoing projects, or that are not FEMA eligible for emergency sand.

Third Amendments with Contractor and CEI services are scheduled to be approved by the Board on March 20th to include the dune restoration project from R41-R49: from Varn Park to South of the Hammock Dunes.

WASHINGTON OAKS STATE PARK DUNE RESTORATION

\$1.8M FDEP funding (100%).
02/28/2023 Notice To Proceed issued.
Advance payment forms sent to FDEP to eliminate financial impact to the County.
Construction has begun, and restoration work on this 4000 feet of shoreline (north of the FEMA Dorian restoration area) is projected to be completed by 03/23/2023.

FEMA PROJECT PW215 - HURRICANE DORIAN

Public Assistance funding from FEMA for \$2,036,868 (75%) and from FDEM for \$339,478 (12.5%), with local cost share of \$339,478 (12.5%).

Project scope includes 49,544 cubic yards of sand and 69,612 dune plants. It covers eligible portions of northern County coastline (5 miles). Sand placement was completed in February and plantings underway in March. Posts and ropes will be installed to protect the dunes and new vegetation.


