

# Household Hazardous Waste Disposal Tips

## BUY ONLY WHAT YOU NEED

Before you buy, check to see if there's a safer alternative. Don't buy more than you think you'll use. This will save the trouble of having to dispose of waste material.

## USE IT UP

This is a simple way to avoid creating waste. For example, spread old fertilizer on your lawn or use the drain cleaner in the drain even if the shelf life has passed.

## GIVE IT AWAY

Friends, neighbors or community organizations may be able to use products you no longer need.

## DISPOSE OF IT PROPERLY

Follow the disposal instructions on the label or contact the Flagler County Landfill at 517-2075 for information. Household hazardous material should be kept in its original container. If it is mixed or stored in a separate container, the container should be clearly marked and labeled to identify the contents.



## Electronic Waste (e-waste)

The term “e-waste” is applied to consumer electronic equipment that is no longer wanted. E-waste can include computers, printers, televisions, VCRs, cell phones, fax machines, stereos, electronic games, hair dryers, radios, alarm clocks, and many other common household electrical items (excluding large appliances).

## Recycling

Curbside recycling is offered in Flagler County by your respective waste hauler. Plastic and glass bottles, aluminum and steel cans, cardboard and newspaper are the recyclables collected curbside. In addition to curbside pickup, Flagler County offers a Recycling & Household Hazardous Waste Collection Facility for residents to drop off recyclable materials. If you need a recycle bin, you can contact your waste hauler or call 517-2075 to arrange to pick one up.
