**T-HANGAR CONSTRUCTION** - The contractor has submitted the request for an additional 45 calendar days due to the FPL coordination issues, labor shortage issues, and weather-related delays. The new substantial completion date is November 30, 2023, and the final completion date is December 30, 2023. S. E. Cline (contractor) completed the construction of the T-Hangar concrete entrance ramps and is in the process of constructing the taxilanes and the connector road. Some sod has been installed between the concrete entrance ramps. M&M Development & Construction (sub-contractor) are in the final stages of completing all of the new T-hangar buildings. The bathrooms are almost complete. FPL installed power to the buildings.

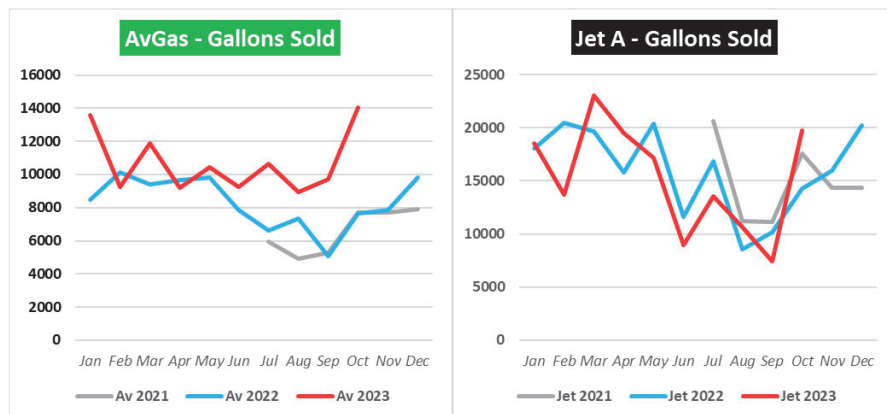
**AIR TRAFFIC CONTROL TOWER EQUIPMENT** - All the equipment has been received. The contractor plans to pour the new AWOS antenna pad in mid-November and then come back at the beginning of December to finalize the installation.

**TAXIWAY A** - No update since last month. The project is on temporary hold until the paving of the taxilanes is completed for the T-Hangar project.

**GENERAL AVIATION TERMINAL RAMP** - The Airport Director issued the Notice to Proceed to Halifax Paving (contractor) on October 2, 2023. Halifax Paving has completed the concrete and pavement demolition operations on the airside. They are now constructing the ramp subgrade. 4C's (subcontractor) has completed the installation of drainage pipes and structures in the landside area of the project.

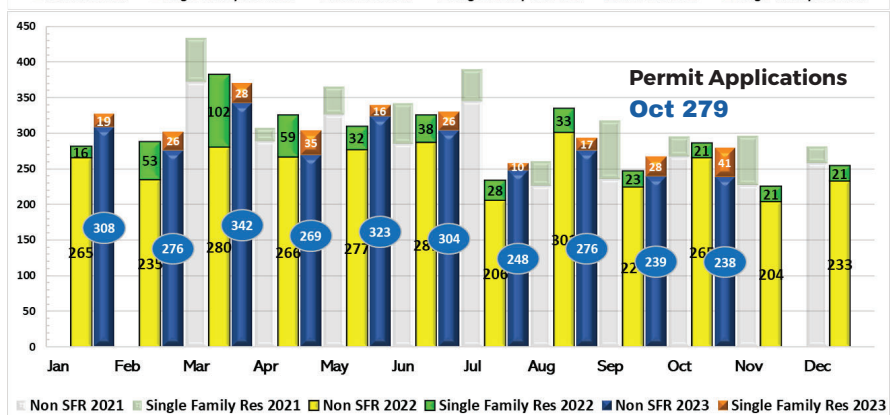
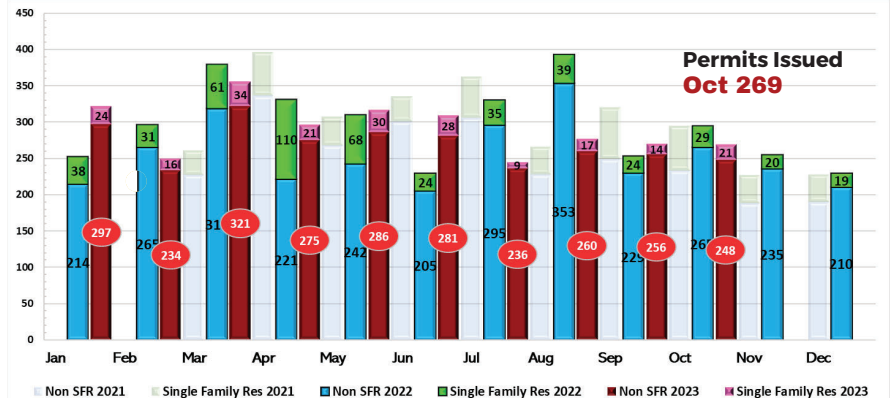
# GROWTH MANAGEMENT: OCTOBER

- The Planning Division is working with the GIS Division on project mapping.

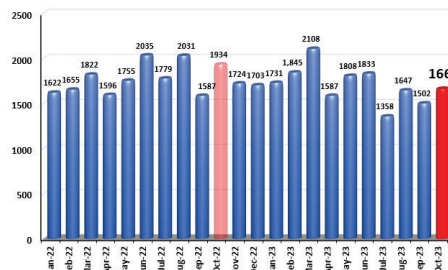

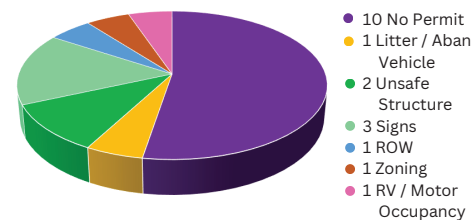

# ENGINEERING UPDATES

## COASTAL PROJECTS - SEPT/OCT

### ACOE/ FDOT PROJECTS CITY OF FLAGLER BEACH

Completion of easement procurement. Funding assistance coordination continues.

Final design, permit modifications/updates, BOEM lease updates and finalization of easements (by Legal) in process. Preparation for construction phase approaches (Spring/Summer 2024). Multi-agency coordination continues. County and ACoE executed a Memorandum of Understanding to enable the ACOE to incorporate the non-fed project limits into the Federal project construction.

### HURRICANE IAN & NICOLE RECOVERY PROJECT - PAINTERS HILL

Completed dune construction at the end of May. Plantings completed in June. Reimbursement and close-out in progress.

### HURRICANE IAN & NICOLE RECOVERY PROJECT - SOUTH HAMMOCK

Dune construction began June 1 and completed June 30. Plantings complete July 15. Reimbursement and close-out in progress.

### HURRICANE IAN & NICOLE EMERGENCY SAND FDEP \$35 MILLION

Approximately \$36.25 million remains after the South Hammock Dunes project and plantings for FEMA Cat B project. Funds to be used for design and permitting of beach and dune nourishment dredge projects along the northern 11.6 miles.

### WASHINGTON OAKS BEACH & DUNES

Advance payment forms sent to FDEP to eliminate financial impact to the County. Work is 100% FDEP funded. Construction complete. Project closeout in progress.

### HURRICANE DORIAN - FEMA PROJECT PW215

Sand placement was completed at the end of February. Reimbursement and closeout in process.

### BEACH MANAGEMENT PLAN

Beach Management Plan was adopted by the BOCC on Oct. 16. It includes the goals and implementation strategies to develop the future management activities and projects along the Flagler County coastline. Funding Study commenced March 9 and is ongoing. Public information webpage is completed.

### HURRICANE NICOLE - FEMA CATEGORY B

Dune construction began July 5 for Hammock Beach Phase 1 section and completed Sept. 14. Phase 2 began Sept. 21 and continues. Planting completed for Phase 1 and half of Phase 2.

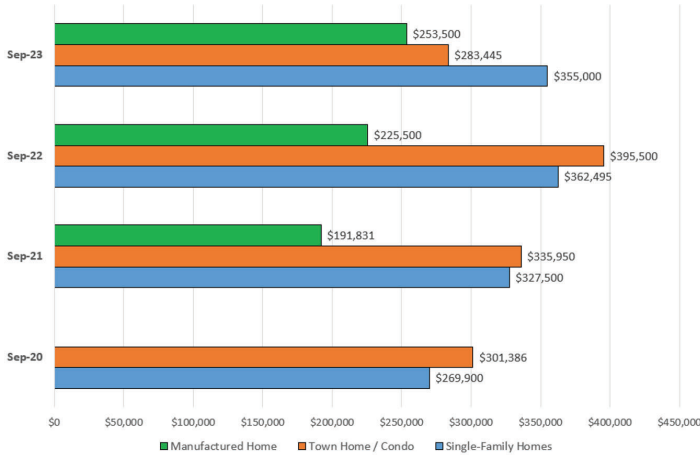

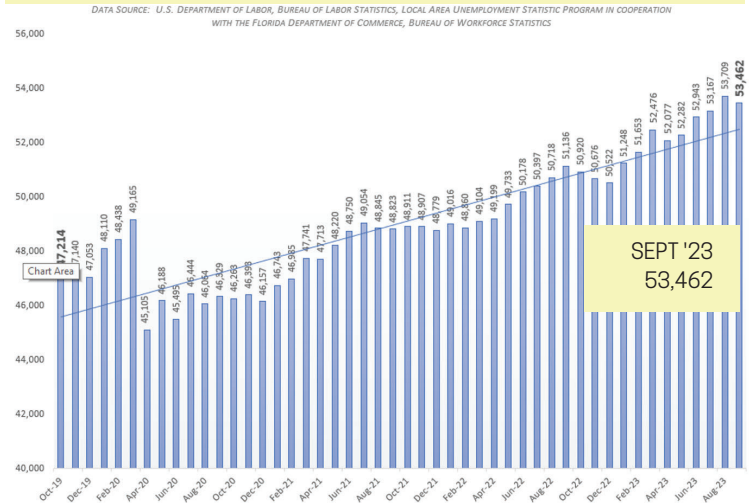

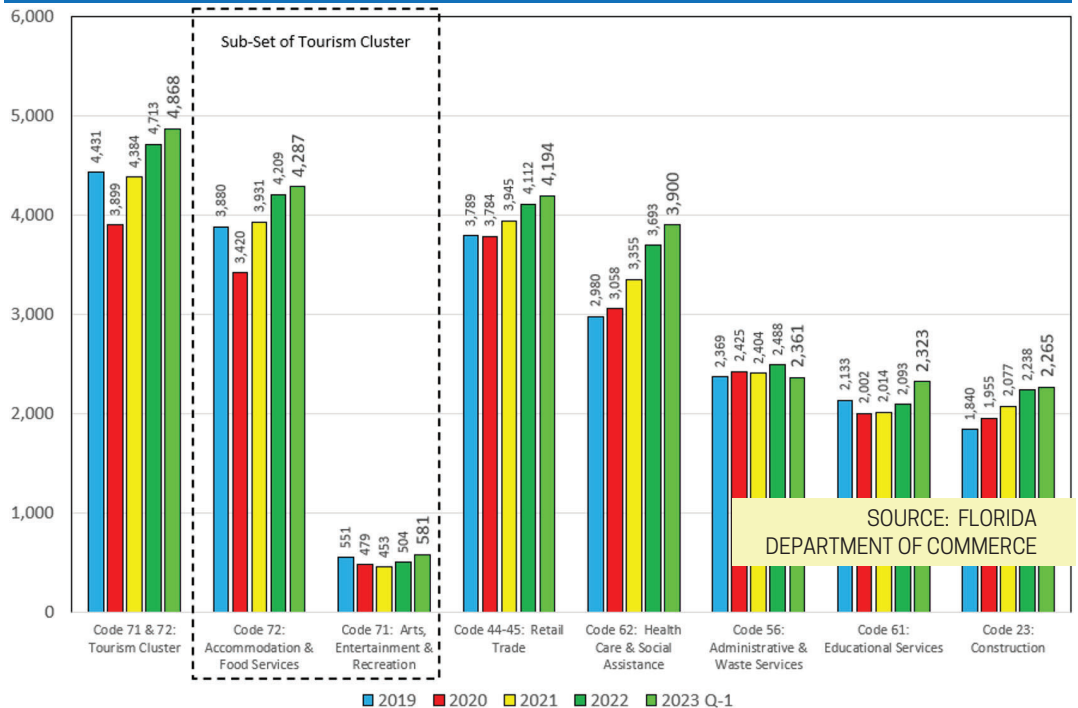
### REAL ESTATE

- September saw a decline in the dollar volume of residential sales in Flagler County. This follows a typical pattern with more sales occurring in Spring and Summer months

### LABOR FORCE

- According to the most recent data, approximately 250 individuals left the Flagler County labor force between August & September
- There were also 252 fewer Flagler County citizens that were employed. This accounts for increase in the unemployment rate
- The unemployment rate rose to 4% in September - the highest rate since November 2021. Unemployment of 5% or lower is often considered full employment in a real-world context.
